

LICENSING MECHANICAL RIGHTS



Can usually be licensed via the collective licensing system this is good because licensees don't always know what songs are being exploited let alone who wrote them / who owns them.

No collecting society for mechanicals in the US - instead the licensee must find the rights owner and then provide the paperwork and payment required by copyright law.

COMPETITION LAW

Competition law concerns about collective licensing are dealt with in different ways in different countries.

In US - BMI and ASCAP are regulated by consent decree - the most draconian regulation despite BMI and ASCAP having no exclusive rights.

Not unique to the US system - but rate courts and royalty board frequently set royalty rates below market value.
